_____ I understand that, regardless of the reason, any class added after the published drop/add period is not eligible for financial aid (except Open Entry/Open Exit [OE/OE] course) and any class that is institutionally dropped for nonattendance, I will not receive financial aid for.

_____ I understand that, to be eligible for financial aid, I must ATTEND my classes and if I fail to attend the entire semester, withdraw from all of my classes, or fail all of my classes, I may be required to pay back a portion of my financial aid.

_____ I understand that I must maintain Satisfactory Academic Progress (SAP) to continue to be eligible for financial aid. SAP requires that I complete 67% of my credits and earn a 2.0 GPA both for the semester and overall.
